Overview

The Loch Long Crime Writing Residency is a new fully funded residency for Scotland-based writers developing new work in crime fiction. This two-week residency is scheduled to take place from Monday 18 March to Sunday 31 March 2024.

About Cove Park

Cove Park is a residency for national and international artists working in all art forms and at every career stage. It is located on an outstanding rural site overlooking Loch Long in Argyll on Scotland's beautiful west coast.

Fiction and non-fiction writers, poets, playwrights, and literary translators have been a key part of our programme since its launch in 2000. Cove Park supports research and the development of new work, hosting those writing in all languages and paying particular attention to Gaelic and Scots. Former residents include Margaret Atwood, Ann Carson, Rachel Cusk, Fred D'Aguiar, Rodge Glass, Rody Gorman, Alasdair Gray, Jeda Pearl Lewis, Kirsty Logan, Rona Macdonald, Heather Parry, Andrew Rubens, Geetanjali Shree, Nicola White, and Louise Welsh, amongst many others. We also devise international writing and translation exchange residencies and host public readings and events.

Loch Long Crime Writing Residency 2024

This is a new funded residency made possible with support from Cove Park's Argyll Patrons / <u>Argyll Associates</u> programme. It builds upon our ongoing commitment to the development of new writing in Scotland.

Key Points

- The writer should be developing new work in crime fiction, including but not limited to sub-genres such as psychological or legal thrillers, detective fiction, police procedurals, or private eye.
- The writer will receive a total residency fee of £1,100 (£550 per week) and a travel allowance of up to £75.
- The residency is designed to support research and the development of new writing.
- Cove Park's team will support research and practical requirements leading up to and during the residency.

What Cove Park Provides

- Individual private accommodation with Wi-Fi on site at Cove Park.
- Private workspace and 24-hour access to the Jacobs Building, including communal meeting rooms, a library, open-plan kitchen, dining area, and laundry facilities.
- Unlimited access to the 50-acre site.



Who Can Apply, How to Apply, Shortlisting and Appointment Process

- Writers based in Scotland.
- Writers who have published, with a traditional publisher, at least one book.
- Writers established in other genres but wishing to develop a crime writing project are also welcome to apply.

Applications can be submitted via the online Application Form.

The Application Form must include:

- Full name and contact details
- A statement (no more than 500 words) briefly describing current work, the reasons for your interest in this residency, and how the opportunity will be of benefit to your work and professional development.
- A sample of work of up to 1000 words (no more than 4 pages)
- A CV and short biography of up to 200 words

We can accept submissions in audio or video formats if this is preferable to a written application. If you consider yourself to have a disability, please tell us if there are any reasonable adjustments to the application process that would be of assistance to you. If you would like to discuss this, or need help making your application, please contact Cove Park's Programmes & Communications Producer <u>Alex Marrs</u> directly.

Selection for interview will be based on the following criteria:

- The creative strength of your work and ideas.
- Your need for a period of research and development and your reasons for applying to this programme.
- Your interest in working within a community of artists.

Deadline for applications: Monday 4 December 2023 at 6pm GMT

We will acknowledge receipt of your application as soon as it is received. This acknowledgement will include a link to our anonymous Equality, Diversity & Inclusion monitoring form for completion and we would be grateful for your time with this. If you do not receive this acknowledgement, please contact Cove Park directly to confirm receipt of your application.

The applications will be short-listed for interview by Cove Park Staff and Advisors.

All applicants will be notified if their submission has been shortlisted for interview by Monday 11 December 2023.

Interviews will take place via Zoom during the week of Monday 18 December 2023.
